

VERIFICATION STATEMENT GREENHOUSE GAS EMISSIONS

Bureau Veritas North America, Inc. (BVNA) was engaged to conduct an independent verification of the greenhouse gas (GHG) emissions reported by Seagate Technology LLC (Seagate) for the period stated below. This Verification Statement applies to the related information included within the scope of work described below.

The determination of the GHG emissions is the sole responsibility of Seagate. BVNA's sole responsibility was to provide independent verification on the accuracy of the GHG emissions reported, and on the underlying systems and processes used to collect, analyze and review the information.

Boundaries of the reporting company GHG emissions covered by the verification:

- Operational Control
- Global

Emissions data verified:

- Scope 1: 262,343 metric tons of CO₂ equivalent
- Scope 2 (location-based): 894,885 metric tons of CO₂ equivalent
- Scope 2 (market-based): 918,536 metric tons of CO₂ equivalent

Data and information supporting the Scope 1 and Scope 2 GHG emissions assertion were historical in nature and in some cases estimated based on historical data for similar properties in similar locations.

 - o Capital Goods: 130,000 metric tons of CO₂ equivalent

 - o Upstream Leased Assets: 3,000 metric tons of CO₂ equivalent
 - o **Downstream Transportation and Distribution:** 16,000 metric tons of CO₂ equivalent
 - o Processing of Sold Products: 2,400 metric tons of CO₂ equivalent
 - o Use of Sold Products: 11,000,000 metric tons of CO₂ equivalent
 - o End of Life Treatment for Sold Products: 100,000 metric tons of CO₂ equivalent

Data and information supporting the Scope 3 GHG emissions assertion were in some cases estimated rather than historical in nature.

• January 1, 2017 through December 31, 2017

- World Resources Institute (WRI)/World Business Council for Sustainable Development (WBCSD) Greenhouse Gas Protocol (Scope 1 and 2)
- WRI/WBCSD Greenhouse Gas Protocol Corporate Value Chain (Scope 3) Accounting and Reporting Standard (Scope 3)

GHG Verification Protocols used to conduct the verification:

Level of Assurance and Qualifications:

- Limited
- Materiality Threshold: ±5%

GHG Verification Methodology:

- Interviews with relevant personnel of Seagate and their consultant;
- Review of documentary evidence produced by Seagate;
- Review of Seagate data and information systems and methodology for collection, aggregation, analysis and review of information used to determine GHG emissions; and
- Audit of sample of data used by Seagate to determine GHG emissions.

Assurance Opinion:

Based on the process and procedures conducted, there is no evidence that the GHG emissions assertion shown above:

- is not a fair representation of the GHG emissions data and information; and
- has not been prepared in accordance with the WRI/WBCSD GHG Protocol Corporate Accounting and Reporting Standard and the Corporate Value Chain Accounting and Reporting Standard

It is our opinion that Seagate has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions for the stated period and boundaries.
